APPROVAL CRITERIA

Requests for additional quantity, up to a 32 day supply for chemoprophylaxis as noted in the chart below, may be approved for the following (IDSA, 2009):

- I. Individuals less than 9 years of age who are newly vaccinated will require a minimum of 6 weeks of chemoprophylaxis, depending on the length of delay between administration of the two required vaccine doses (IDSA, A-I);

OR

- II. Individuals in an institutional setting (such as, long-term care facilities) who are either residents (regardless of vaccination status) or employees who are unable to receive influenza vaccine will require chemoprophylaxis for 14 days OR for 7 days after the onset of symptoms in the last person infected, whichever is longer (IDSA, A-I).

Note:

Chemoprophylaxis dosing for Tamiflu (oseltamivir) is as follows:

- a. Adults: 75 mg once per day
- b. Children (age greater than or equal to 12 months): Weight based
 - i. Less than or equal to 15 kg: 30 mg once per day
 - ii. 15-23 kg: 45 mg once per day
 - iii. 24-40 kg: 60 mg once per day
 - iv. Greater than 40 kg: 75 mg once per day
