### APPROVAL CRITERIA

Requests for Venclexta (venetoclax) may be approved if the following criteria are met:

- I. Individual has a diagnosis of relapsed/refractory Chronic Lymphocytic Leukemia (CLL) with or without 17p deletion (label, NCCN 2A); **AND**
- II. Individual has received at least one prior therapy;

**OR**

- III. Individual has a diagnosis of relapsed/refractory Small Lymphocytic Lymphoma (SLL) with or without 17p deletion (NCCN 2A);

**OR**

- IV. Individual has a diagnosis of Mantle Cell Lymphoma (NCCN 2A).

**Note:** Concomitant use of Venclexta (venetoclax) with strong inhibitors of CYP3A at initiation and during ramp-up phase is contraindicated.
