APPROVAL CRITERIA

Requests for Zytiga (abiraterone acetate) may be approved if the following are met:

- I. Individual has a diagnosis of metastatic castration-resistant* prostate cancer (CRPC);
OR
- II. Individual has a diagnosis of metastatic high-risk castration-sensitive prostate cancer (CSPC);

AND

- III. Individual is using in combination with prednisone.

*Castration-resistant refers to disease progression following either surgically or medically-induced methods of castration. Medically-induced methods of castration include luteinizing hormone-releasing hormone (LHRH) agonists [such as, leuprolide and goserelin) or LHRH antagonists (such as, degarelix).

Note: Metastatic castration-resistant prostate cancer occurs when cancer has metastasized beyond the prostate and disease progresses despite serum testosterone below castrate levels.
