

**KMAP GENERAL BULLETIN 18138**

**Covered Telemedicine Services Codes**

Effective with dates of service on and after August 15, 2018, the following codes may be used for reporting synchronous (real-time) telemedicine services when billed with place of service (POS) 02. Procedures involve electronic communication using interactive telecommunications equipment that includes, at minimum, audio and video. Telemedicine equipment must be compliant with the Health Information Privacy Protection Act (HIPAA). The HCPCS codes are designated for use via telemedicine through prior Kansas Medical Assistance Program (KMAP) publications or code descriptions.

These codes are appropriate to be furnished via telemedicine, but providers must ensure the codes are covered by KMAP. Codes not appearing in the table below are not covered as telemedicine codes.
