Re: Important information regarding alpha-hydroxyprogesterone caproate (17P) coverage

Dear Provider:

To support your efforts in preventing preterm delivery in women who have high-risk pregnancies, Amerigroup Kansas, Inc. has a program to ensure physicians are aware of members who may benefit from progestin therapy. You will receive an alert listing members on your panel identified through our high-risk screening survey as potential candidates for progestin therapy. Each alert will be sent with an order form to be used when requesting injectable compounded 17P for office administration. This is an optional service, and you may request to discontinue receiving these alerts at any time.

If you wish to prescribe progestin therapy for your patients, the following delivery and administration options are available:

- For office administration of compounded 17P, please contact a participating pharmacy.
- If home health services are required for administration, please complete a referral to Alere Home Health. Contact Alere at 1-800-999-9428 to request a referral form.
- If Makena™ is required, please call Express Scripts at 1-855-201-7170 to initiate a precertification request.

For your convenience, a list of 17P compounding pharmacies in the Amerigroup network is attached.
