The Bureau of TennCare invites you to attend a QuILTTS Community Forum.

QuILTSS stands for Quality Improvement in Long-Term Services and Supports (LTSS).

QuILTSS is a TennCare project to increase the quality of LTSS provided to TennCare members. LTSS include nursing home care as well as home and community based services (HCBS) for seniors and adults who have a physical disability.

QuILTSS will help select ways to measure quality that are most important to people who receive LTSS and their families. These measures will be used to develop a new way to pay for nursing home services and for some kinds of HCBS. In the future, part of what a nursing home is paid will depend on the quality of services they deliver. Nursing homes providing higher quality care will be paid more. Those who do not perform as well on quality measures will earn less. The same will apply for providers of some kinds of HCBS.

Tennessee has been awarded a grant from the Robert Wood Johnson Foundation to help with QuILTSS. The grant provides funding for technical assistance to TennCare. The funding has been awarded to Lipscomb University under a contract with Princeton University. Lipscomb is helping TennCare get your input about the quality measures that will be used to pay for LTSS.

To gather input on this important project, TennCare is hosting QuILTSS Community Forums across the state. This is your chance to join others from your community in helping develop this program. It is very important for your voice to be heard.

The 90-minute QuILTSS Community Forum will include an overview of QuILTSS, as well as other current national and state level quality efforts. Most of the time will be spent working in small groups. You will be able to provide input about the kinds of quality measures that are the most important to people actually receiving LTSS. This is your chance to help create a system focused on paying for value and on improving the quality of care that LTSS members receive. Staff from Lipscomb University's School of TransformAging® will be leading the forums.
