<b>Active&amp;Fit® program</b>	Our Active&Fit program is specifically designed to maintain muscle tone, while increasing strength, flexibility, mobility and improve overall health. Achieving personal fitness goals can improve overall health and well-being. Through this program, enrollees have the opportunity to improve fitness levels, develop a support system and work with online professionals that guide the attainment of fitness goals. <b>Extracurricular support</b>	Eligible enrollees will receive a \$50 allowance to help them cover the cost of afterschool extracurricular clubs and activities, such as debate team, student newspaper, instrument rentals, afterschool sports (e.g., football, soccer, track, gymnastics, dance and/or karate). <b>Mail order diapers</b>	Eligible enrollees can receive 400 diapers shipped directly to their home free of charge. 	All enrollees are eligible.	Enrollee must be caretaking for a child that requires diapers.	Limit one benefit per enrollee, per year
<b>Asthma Support Program</b>	Our Asthma Support Program is a digital respiratory management solution for people with asthma. This benefit includes a telemonitoring platform comprised of a combination of sensors that snap onto inhalers, smartphone applications, care management tools and advanced analytics to help track time and location when inhaled medications are used and help encourage proper medication adherence. <b>Free additional phone minutes</b>	Amerigroup works with Safelink Wireless® to provide mobile phone service. Enrollees receive 200 free bonus minutes when they sign up and 100 bonus minutes on their birthdays.
