**Subject: Modifier 78: Unplanned Return to the Operating/Procedure Room by the Same Physician Following Initial Procedure for a Related Procedure During the Postoperative Period**

These policies serve as a guide to assist you in accurate claim submissions and to outline the basis for reimbursement if the service is covered by a member's Amerigroup benefit plan. The determination that a service, procedure, item, etc. is covered under a member's benefit plan is not a determination that you will be reimbursed. Services must meet authorization and medical necessity guidelines appropriate to the procedure and diagnosis as well as to the member's state of residence. You must follow proper billing and submission guidelines. You are required to use industry standard, compliant codes on all claim submissions. Services should be billed with CPT codes, HCPCS codes and/or revenue codes. The codes denote the services and/or procedures performed. The billed code(s) are required to be fully supported in the medical record and/or office notes. Unless otherwise noted within the policy, our policies apply to both participating and nonparticipating providers and facilities. If appropriate coding/billing guidelines or current Reimbursement Policies are not followed, Amerigroup may:

- Reject or deny the claim.
- Recover and/or recoup claim payment.

Amerigroup reimbursement policies are developed based on nationally accepted industry standards and coding principles. These policies may be superseded by mandates in provider, state, federal or CMS contracts and/or requirements. System logic or setup may prevent the loading of policies into the claims platforms in the same manner as described; however, Amerigroup strives to minimize these variations.

Amerigroup reserves the right to review and revise our policies periodically when necessary. When there is an update, we will publish the most current policy to this site.

**Policy**

Unless provider, state, federal or CMS contracts and/or requirements indicate otherwise, Amerigroup allows reimbursement for claims billed with Modifier 78 when the following criteria are met:

- The return to the operating or procedure room is unplanned.
- The procedure appended with Modifier 78 is:
  - The appropriate surgical code for the procedure performed.

	<ul style="list-style-type: none"> <li>○ Performed by the same physician who provided the initial procedure.</li> <li>○ Related to the initial procedure.</li> <li>○ Performed during the postoperative period of the initial procedure.</li> </ul> <p>Reimbursement is based on 70 percent of the fee schedule or contracted/negotiated rate of the surgical procedure code when the modifier is valid for the service performed. Reimbursement is based on the surgical procedure <b>only</b> and does not include preoperative or postoperative care. Procedures rendered during the postoperative period and not billed with Modifier 78 are normally denied as included in the global surgical package.</p> <p>When an assistant surgeon is used and/or multiple procedures are performed during the global period in the same operative session, assistant surgeon and/or multiple procedure rules and fee reductions apply.</p> <p><b>Nonreimbursable</b>  Amerigroup does <b>not</b> allow reimbursement for Modifier 78 billed in the following circumstances including but not limited to:</p> <ul style="list-style-type: none"> <li>● With nonsurgical codes</li> <li>● With codes denoting “subsequent,” “related” or “redo” in the description</li> </ul>
<b>Exemptions</b>	<ul style="list-style-type: none"> <li>● Amerigroup in Florida in compliance with Florida’s Agency for Health Care Administration (AHCA) Medicaid Services Coverage and Limitations Handbooks: <ul style="list-style-type: none"> <li>○ Does not reduce reimbursement of codes billed with Modifier 78.</li> <li>○ Allows the use of Modifier 78 with anesthesia claims.</li> <li>○ Allows reimbursement for Modifier 78 for same physician or physician’s group.</li> </ul> </li> <li>● Amerigroup Kansas, Inc., in accordance with Kansas Medical Assistance Program (KMAP), reimburses services appended with Modifier 78 the appropriate percentage as indicated in the MPFSDB (Medicare Physician Fee Schedule Data Base). For those procedure codes that have surgical indicator “YYY” and are assigned a global period of 010 or 090 days, reimbursement of Modifier 78 is 80 percent.</li> <li>● This policy is not applicable to Amerigroup Louisiana, Inc.</li> </ul>
